USE AND SAFETY INFORMATION

Surface Preparation: All surfaces must be clean and free of mold, mildew and any previous finishes. Check for porosity by applying a few drops of water. If the water is quickly absorbed, the surface is ready for application. To check for acceptable appearance, always apply to a small test area and allow to dry prior to coating larger areas.

Application: Shake container before using. Apply a generous coat with a low pressure sprayer, synthetic brush or roller. Apply a uniform coat, avoid pooling or drips. This product should fully penetrate into surface within 10 minutes. Single coat application is recommended. Re-apply every 1-2 years, depending on exposure. Recently treated surfaces may be slippery until dry and weathered. Coverage 100-250 sq. ft./gallon depending on surface. Dries clear in one hour. Complete drying depends on temperature, humidity and porosity of surface.

Cleanup and Disposal: Cleanup brushes and equipment with soap and water. Dispose of unused material in accordance with local, state and federal regulations. Close container after each use.

Protect from Freezing: Do not apply at temperatures below 40° F. during application and drying. Do not apply to painted or sealed surfaces. Do not thin or mix with other products.

CAUTION: May be harmful if swallowed. Avoid breathing vapors or spray mist. May be irritating to eyes and skin. Use goggles and protective clothing to avoid exposure. If you experience eye watering, headaches or dizziness, increase fresh air or leave the area. Keep container closed when not in use. Do not transfer to unlabeled containers.
